Mr. Vidales called the meeting to order at 12:06 p.m. noting the presence of a quorum.

The Authority's Community Investment Committee ("CIC") met to discuss, consider and take legal action as determined on the following:

1. APPROVAL OF MINUTES OF THE COMMUNITY INVESTMENT COMMITTEE HELD ON JUNE 2, 2015 AND JULY 7, 2015.

Mr. Vidales referred to the minutes distributed in the Committee Member packages.

MOTION by Mr. Thompson and seconded by Mr. McAllister to approve the minutes from the June 2, 2015 Community Investment Committee meeting.

The motion passed unanimously by a vote of (4-0).

MOTION by Mr. McAllister and seconded by Mr. Stawiecki to approve the minutes from the July 7, 2015 Community Investment Committee meeting.

The motion passed by a vote of (3-0). Mr. Thompson abstained from voting.

2. DISCUSSION AND ACTION AS DETERMINED REGARDING GRANT REQUESTS SUBMITTED TO THE ARIZONA COMMUNITY FOUNDATION AND RECOMMENDED TO THE AUTHORITY'S COMMUNITY INVESTMENT COMMITTEE.

The Committee Members reviewed 10 applications that had been previously submitted through and vetted by Arizona Community Foundation ("ACF"), and considered feedback from Bruce Liggett, Director of the Maricopa County Human Services Department, along with Morgan Bishop (Philanthropic Advisor – Grants Management) and Vince Yanez (Executive Director of Education and Public Policy) both of ACF.

There were brief updates on the status of the Nova audit relating to the Home in Five Program, along with updates regarding a revised verbal request from Trellis, a

possible \$1.5 million grant received by Coffelt-Lamoreaux, the draft consulting agreement for the hiring of Ghelfi Consulting for Business Development Officer, the Velocity program, EWI, and the Men's Overflow Shelter.
