Mr. McAllister called the meeting to order at 12:05 p.m. noting the presence of a quorum.

The Authority's Community Investment Committee ("CIC") met to discuss, consider and take legal action as determined on the following:

1. APPROVAL OF MINUTES OF THE COMMUNITY INVESTMENT COMMITTEE HELD ON MARCH 1, 2016.

Mr. McAllister referred to the minutes distributed in the Committee Member packages.

MOTION by Mr. Stawiecki and seconded by Mr. Westad to approve the minutes from the March 1, 2016 Community Investment Committee meeting.

The motion passed unanimously by a vote of (4-0).

PRESENTATION BY JUAN SALGADO OR ANOTHER REPRESENTATIVE 2. OF THE INDUSTRIAL DEVELOPMENT AUTHORITY OF THE CITY OF **PROPOSED** PHOENIX, ARIZONA ("PIDA") REGARDING THE COMMUNITY VENTURES, LLC OF PURCHASE FROM RAZA APPROXIMATELY 80.42 ACRES OF LAND LOCATED IN THE CITY OF PHOENIX, FOR FUTURE DEVELOPMENT; A REQUEST THAT THE AUTHORITY JOIN WITH PIDA IN THE PURCHASE OF SUCH REAL PROPERTY; AND ACTION AS DETERMINED.

The following persons were in attendance in support of this request: Juan Salgado, Executive Director of The Industrial Development Authority of the City of Phoenix, Arizona ("PIDA"); Christine Mackay, Director of Community and Economic Development for the City of Phoenix; Tommy Espinoza, President and CEO of Raza Development Fund; Sharon Harper of Plaza Companies; and Paul Magallanez, Community/Economic Development of PIDA.

Christine Mackay gave an overview of the proposed project, known as Plaza de las Culturas, which will consist of medical, residential (including assisted living), educational uses, retail, and office space. The project is anticipated to take at least 10 years to develop. Ms. Mackay discussed the various phases of development.

Ms. Mackay said the City of Phoenix Council is planning to consider participating in the public infrastructure within the project, i.e. roads, sewer, water.

Mr. Salgado explained that Raza Community Ventures, LLC ("Raza") currently has the property under contract with its current owner, CEMEX, USA, and the Authority and PIDA are being asked to buy Raza's position.

Mr. Salgado said they were seeking approval to: (a) enter into a letter of intent to perform due diligence to purchase approximately 80.42 acres located between Central Avenue and 7th Avenue within the city of Phoenix; (b) authorize each industrial development authority ("IDAs") staff and their legal counsel to negotiate on behalf of the IDAs and incur reasonable expenses; and (c) spend necessary funds, including a fully-refundable earnest money deposit of \$100,000 to be placed into escrow.

There was then a discussion on the remediation of the property.

Mr. Wilder cautioned the Committee Members that if they were to move forward with this request, the property would need to be remediated prior to putting the property into the name of the IDAs in order to avoid any future liability.

MOTION by Mr. Westad and seconded by Mr. Stawiecki to recommend to the full Board for further consideration.

The motion passed unanimously by a vote of (3-1).

Messrs. McAllister, Stawiecki and Westad voted aye; Mr. Thompson voted nay.

Ms. Scharbach explained that Mr. Vidales has a conflict relating to this matter and will not participate in any conversations or voting.

3. DISCUSSION AND ACTION AS DETERMINED REGARDING GRANT REQUESTS SUBMITTED TO THE ARIZONA COMMUNITY FOUNDATION AND RECOMMENDED TO THE AUTHORITY'S COMMUNITY INVESTMENT COMMITTEE.
